- 1. The Thompson Women's Training Institute, Cuttack has been recognized by Govt. of Odisha as Secondary Training School w.e.f. 1.7.1965.
- 2. Admission shall be made to the 1<sup>st</sup> Year classes D.El.Ed. Course for the session 2016-2018 in the Thompson Women's Training Institute, Cuttack The detail admission programme in the information brochure available in the Website:

- 3. The Intake capacity in 50 (Fifty)

## **Reservation of Seats:**

- a) 50% of total number of seats will be reserved for the Christian minority community women candidates (25 seats) and 50% for General category (25 seats).
- b) 50% of the total minority Seats (25 seats) will be filled up by the Christian Minority candidates (13 seats) & Dalit Christian candidates (12 seats). In case of non availability of qualified candidates in any category there will be interchange of seats.
- c) Christian students belonging to ST/OBC/SEBC are considered as Dalit Christian. Christian minority candidates shall produce the required documents such as the caste certificate ST/OBC/SEBC along with baptism certificate at the time of admission.
- d) The candidates qualified on the basis of merit of the Entrance Test conducted by the TE & SCERT, Odisha, Bhubaneswar will be provisionally selected for admission in the christian quota subject to production of religion certificate authenticated by the Bishop, Diocese of Cuttack, Church of North India. - e) All Christian candidates shall apply in proper application form (ANNEXURE- I) addressing to the Secretary/Bishop, Diocese of Cuttack, Church of North India, At- Mission Road, Dist. Cuttack with their Baptism Certificate, photo copies of ROR, ST/SEBC/OBC Certificate, Form A under Odisha Freedom of Religion Act- 1989 in case of new converted Christian. They are required to submit a recommendation letter from pastor of their concerned

Churches addressing to the Bishop/Secretary, Diocese of Cuttack, CNI to issue Sponsorship Certificate which will be subjected to scrutiny.

- 4. The following documents in original are to be produced at the time of admission.
- a) Certificates and Mark-sheets.
- b) College Leaving Certificate
- c) Residential Certificate (candidates have to produce their Nativity Certificate in schedule form III issued by the Tahasildar concerned).
- d) Application of Sponsorship Certificate. (Annexure-I)
- e) Baptism Certificate/Confirmation Certificate of self/parents.
- f) Recommendation letter from Pastor of their concerned churches addressing to the Bishop/Secretary, Diocese of Cuttack, CNI to issue Sponsorship Certificate.
- 5. Total institution fees at the time of admission is **Rs.11,362/- (Rupees Eleven thousand three hundred sixty two)**
- 6. **Hostel Accommodation**:

The students may reside in the Hostel of this training institute subject to availability of seats.
